Because I am still digging items out of boxes, I do not have a lot of new details to share, so I decided to go a different route this month. Instead of a profile, I am challenging everyone with a theme to which all families should be able to relate and provide some family details to contribute. I hope for ongoing feedback all year revolving around this timeframe in history.

I would like to present stories throughout this year of Varner experiences during the war years of World War 1. Do not limit input to just those that actually served. Accounts of everyday life at the time would also be very interesting.

The only Varner who I have personal knowledge of serving during "The Great War" was Clarence Sheridan Varner (1895-1988). While I do not have much information yet on this part of his story, I hope to study it further and obtain input from his descendants to round out a fuller picture of his life while in the service.

I currently have only the most basic information about this part of my great uncles, **Clarence Sheridan⁷ Varner** (John⁶, Nancy⁵, George⁴, Fredrick³, John², Hans¹) life. My knowledge is limited to the fact that Sheridan served in the US Army, and was in the 52nd Balloon Squadron. I intend to search

records and have conversations with direct descendants to provide additional details in a future issue.

VARNER'S & WORLD WAR I

History from the war years: 1914 to 1919.

This year marks the 100th anniversary of the start of World War 1. Like many other times in history, I think that we tend to overlook this period. The timeframe is really fascinating and I know that this war touched most everyone at the time.

While we gather more Varner family details about this period, I have used this space to provide some history about "The War to End All Wars".

The roots of this first true "World War" occurred in and around the Balkans and well documented. are Many longstanding political and ethnic differences culminated in the assassination of Archduke Ferdinand and his wife on 28 June, 1914. Anyone with an interest can find much intriguing information on the subject.

Austria declared war with Serbia on 28 July, 1914. Germany declared war with Russia on the 4th of August, 1914. Germany then declared war with France on 3 August and Britain on 4 August, 1914.²

The United States at the time was very isolationist and did not actually enter the war until 4 April, 1917. Several factors precipitated entry of the US. Germany's harassment and sinking of US merchant ships, and discovery of Mexico's talks with Germany to possibly enter the war on Germany's side.³

While the period of formal war participation by the United States spanned only slightly over two years, significant effort to the war was provided by the United States which affected the whole nation.

At the entry of the United States into the war, the Congress created the

Selective Service Act. This act required all males 21 to 30 years of age to register for military service. A year later the act was amended to include all males 18 to 45 years of age.⁴

During the period of US participation in the war over 4 million men entered military service.⁵

The American Protective League was created and worked with the Federal Bureau of Investigation to support the war and at the same time identify slackers, spies, draft dodgers and antiwar organizations.⁶

The Espionage Act of 1917⁷ and the Sedition Act of 1918⁸ attempted to punish enemy activity and extended to the punishment expressions of doubt about America's role in the war. The Sedition Act criminalized any expression of opinion that used "disloyal, profane, scurrilous or abusive language" about the U.S. government, flag or armed forces.

Liberty gardens were promoted to encourage people to plant their own vegetables to help reduce pressure on the food supply during the war.⁹

As has always been the case during conflicts, the ultimate loyalty of immigrants was questioned and such individuals were looked upon with suspicion. Many citizens of recent German extraction were interned for the duration of the war.¹⁰

Campaigns were launched to encourage people to buy "Liberty Bonds". 11

Also occurring during this timeframe was the flu pandemic of 1918. The 1918 flu pandemic (January 1918 – December 1920) was an unusually deadly influenza pandemic. It infected 500 million people across the world and killed 20 to 40 million. ¹²

Wartime censors minimized early reports illness of and mortality. However newspapers were free to report on the pandemic's effects in neutral Spain, creating false impression of Spain as especially hard
