QUESTIONS / NEWS

Q) From Vivian Sibyl (Bruce) Kessler: "The James C. Piles you cited [Sic-Newsletter] as being an administrator for the estate of Edmund Riggs. Was he the James Carroll Piles who married Emily Jane Berry, daughter of Phillips Hawkins Berry and Mary "Polly" Jenkins? I have him in my tree because Rachel Jenkins Newton, my ggg-grandmother, also married Phillip Berry."

A) Yes he was. I believe he is also mentioned in other spots in the Edmund

Riggs estate documentation. Edmund Riggs wife was Mary Ann Elizabeth Piles. It is always amazing to see how interconnected everyone is.

Q1) Both from Don & Judy (Silvara) Varner:

Many years ago when Norman Varner was still alive and attending Varner Reunions, he took us to that exact same spot that you mentioned in [Sic-A previous] newsletter. He said that is where his grandfather Samuel buried his parents, George and Harriett. He also took us to the Flaugher farm. He told us that Samuel was buried up on a hill but we would have to get there by tractor or 4 wheel drive.

No one was home so we didn't go looking for the grave. Now I don't remember what Flaugher lived there or if it was where he used to live. It was on Hwy 52 west of Capps Landing.

Q2) There is a man named Noah Adams. He always came to the Varner Reunions. His wife was doing research on the Dallas Co. Varner's. There was a Samuel Alexander Varner living in Miller Co. working for a farmer named Robert Alford about the same time that Samuel Phillip Varner was in Miller Co. in 1860. His father's name was Jacob Varner. The two Samuels are only 10 years apart. Samuel Alexander of Dallas Co. married the daughter of the farmer, Robert Alford. He named one of his sons Bert Owen. His first wife Martha Lucinda Alford died after having 8

children at the age of 32. He married again and had four more. One was Bert Owen. I find that name interesting. I wonder if the two Samuels were cousins?

A1) Cecil Daniel Varner, 05/28/1919-01/11/2012 (William Owen⁶, Nancy Ann⁵, George⁴) is who told me this information. Cecil described where he had been told the location was.

"North out of Tuscumbia on 17. Take first left (about 4 or 5 miles). Goes to Saline Valley State Wildlife Area. After crossing creek as you go up the hill on the left back off of road". There are discrepancies to these directions as the "first" left on 17 comes several times before 4 or 5 miles. Cecil said the this was passed onto him by Francis Logan Varner 12/03/1874-05/06/1939 (Samuel Philip⁵, George⁴), so Cecil heard this story at an age under 20 years old since Francis Logan died in 1939.

About 12 to 15 years ago, after hearing this information from Cecil at a family reunion, dad and I went looking for this location. Cecil did not want to go for health reasons, and because he could not speak from knowing the place, just from being told about it. We limited our search that day to those left turns off of 17 that seemed to go into the wildlife area. There was one that had us

crossing a small creek shortly after turning off of 17 on a gravel road that began climbing a hill. (That road eventually became very rough and travelled completely through the wildlife area, coming out on north/west of the state controlled park. I also remember that we almost drowned the car having to cross a creek where you had to drive right through the creek as there was no bridge.) As further identification for the road we picked as most likely, there were two or three houses on the right or north side of the gravel road in the first ½ mile from 17 even though the road was supposed to be within the wildlife park.

So we did our best to interpret the instructions. The gravel road did seem to level off about ¼ mile in, so we assumed that the area between the creek and the top of the first hill was where we should be. All the land on the left (south) side of the gravel road was either farm, cattle, or fallow acreage. Some behind fence, some not. We looked without success for paths back off the road and for possible old footings or foundations where buildings might have been.

Is this the area were George and Harriet are buried? Maybe. But that assumes we were on the correct gravel road. That it was not in fact much further off the main highway then where we looked. And that Cecil had remembered the directions even half-way accurately

60 years after those instructions had being told to him.

I also recall hearing many years ago from a person I cannot remember now, that stated some of the other family descendants of Nancy's siblings also maintain a legend for the same area.

I have tried to look on Google Earth and relocate the road without success. Everything looks different 15 years later. I assume I would have to go again myself to find the same spot.

I still think that it is worth others looking at this with fresh eyes. Maybe starting from scratch with Cecil's instructions, in hopes of finally locating the spot. The most promising thing about this story is the fact that the area described is not built up. Being in or around the wildlife boundaries have prevented much building from occurring. That gives us a fighting chance that some of the original clues might still be there, somewhere.

I do have some doubts about this location. 1860 census data of the people listed in that census before and after George and Harriet seem to all be closer to what is now Mary's Home. So, the true location might be closer to Mary's Home? The area where Cecil described is 3 to 4 miles from Mary's Home as the crow flies.

I have included two maps at the end of this newsletter that depicts the general

area where Cecil describes George and Harriet's possible place of rest.

Maybe I have misread Cecil's instructions. Can anyone else come up with a different interpretation of the location as provided by Cecil's instructions?

As far as where Samuel is buried. Cecil mentioned that also, but I cannot find any place where I wrote down those instructions.

Dad and I did seem to find the spot that same day. There was someone home at that property. We asked about Samuel Varner's grave and were told that there were some unknown graves up the hill, but it is very hard to get to. The owner suggested that the way we were dressed, and without a guide, we could not find it. I never went back.

It seems (But this is very vague.) that the property is on 52 east out of Tuscumbia which would place it on the east side of the Osage river. Not very far. On the right side of 52. You drive back a long ways on the gravel driveway and get to a single story house. It is not a road, but a driveway as it ends at the house. The area is mostly fenced. To the left as you are facing the house in the driveway is a large hill and that is where the man pointed to the graves being located. He may have said that they had markers, but were not legible.

A2) There is another Samuel Varner in this part of Missouri during our Samuel Philip Varner's lifetime. It is unknown if they are closely related, or related at all? There are members of our Varner family out of Oglethorpe County, Georgia that settled in Tennessee.

We know the history of our Samuel Varner. Lived in Miller County his whole life. What I found about Samuel Alexander Varner is shown below. I have not done any serious research on this myself.

This Samuel Varner does not seem to appear in any censuses after 1910. I have not follow up on any of the descendants. Would be nice to know what if any relationship there is to our Varner family.

A Letter Between Aunt & Niece

A while back Vivian Kessler provided me with a letter written in 1950, from Cora Lee Varner Meads to her aunt Eurelda Varner Newton.

I thought that the letter was in interesting insight to both those families lives and the family in general in that time period. Thank you to Vivian for providing a copy of the letter, and allowing me to reproduce it here.

George Varner of Missouri Direct Line DNA

The stars aligned on August 10th and I was able to meet with Bill Varner (Billy Joe Varner b. 1944) in Versailles. MO.

Bill and I had a long discussion, with me telling him more details of our side of the Varner family and Bill telling me about his line. It appears that none of the living members of Bill's line were really aware of our side of the family. They knew some Varner's were in Camden County, but not the relationship.

Bill provided me with a boatload of information surrounding his siblings, and descendants. The bad news is that as I sit here to put some that information in perspective, I find that it has all been mistakenly thrown away! Apparently, when I recently used the same folder to attend a last minute meeting, I removed the pages of my scribbling and later threw them out. The trash is long gone now, so I guess I will be having another long conversation with Bill to reproduce the same data.......

The good news is that Bill provided the DNA samples!

Family Tree DNA must be very busy right now. I mailed in the sample on the same day it was provided (August 10th). Family Tree DNA however did not post receiving the sample until the 25th. A

check on the website reveals that the expected timeframe for completion of the testing is between November 11th & 25th. So, it looks like we will not know any answers until around Thanksgiving.

Something to look forward to.


